PRESIDENT'S MESSAGE

The Board of Directors held a combined August/September meeting on August 29th. The meeting agenda was primarily a review and update on the projects at Canon del Sol.

In addition, on August 29th, I was contacted by the Santa Cruz County Sanitation Department (SCCSD) to inform me of an incident occurring at our wastewater treatment plant that serves our community. The notice informed me that the plant had "recently experienced a significant upset and mass die off of the organisms in the biological process that treat wastewater." The event that caused this was observed on August 8th, and the work to restore the plant to proper operation took over two weeks. I've since learned that events like this have occurred in the past, and the sources of contamination have been found to be toxic dumping of thinners and solvents in the sewer system.

SCCSD asked me to immediatly notify all owners of this event and distribute an alert document that was provided to us by the county. This message and notice was distributed last week by Anderson and Co., and SCCSD's alert document appears at the bottom of page 3.

The HOA will be working with the SCCSD to provide additional information to our owners regarding disposal of all toxic waste. Further, additional information on this is contained on page 3 of this newsletter and will be posted on our HOA website.

The board will hold its next meeting on October 3rd, in person at the HOA clubhouse. This will be a regular board meeting that will include the counting of the ballots for election to board vacancies.

At the meeting, the ballots for board positions will be counted by our election inspector Diane Lehmann. Please make sure to send in your ballot if you have not already done so. In the event you did not receive one, please contact Anderson and Co., and one can be mailed to you. All ballots

IMPORTANT INFORMATION FOR OWNERS AND RESIDENTS OF CDS REGARDING OUR WASTE WATER TREATMENT SYSTEM

Per the September 2 notice sent to all owners regarding the anonymous dumping of a chlorine/bleach chemical into our CDS waste water treatment system, the following information is provided to help each of us to be mindful and well informed of what we should and should not be dumping into the toilet and/or down the drain.

Toilets: Only three things should be placed into our toilets, personal body waste (urine and feces) and toilet paper. The following items should NOT be placed into the toilet: tissues (aka Kleenex), paper towels, sanitary hygene products, dental floss, condoms, wipes that claim to be flushable, or disposable diapers. This is only a partial list of things we should not be placing into our toilets.

Sinks/drains: No chemicals, among other things.

- How much bleach or other household product may I use at home? As long as you are following the manufacturer's directions, you should be okay. A minimal amout of bleach, for example, as directed to be used in your washing machine, is just fine. The problems develop when an excessive amount is dumped.
- Be mindful of what your contractor, handyman or tradesman may be disposing of to ensure that he or she does not dump something that is harmful to our system.

You will likely minimize your need for a plumber by heeding many of the recommendations about what to put into your garbage disposal and drain.

The 9/2/2022 notice from Santa Cruz County Sanitation Department to our community is repeated below:

ALERT!

Dumping Hazardous Chemicals Down the Sewer Drain is Illegal! This notice is to inform you that there have been several cases of illegal dumping in the sewer system in your neighborhood. CSA 5 - Canon del Sol Wastewater Treatment Plant is experiencing an upset because of a toxic substance discharged in your neighborhood.

It is ILLEGAL and DANGEROUS to pour hazardous chemicals such as solvents and gasoline down the sewer drain, which can create EXPLOSIVE CONDITIONS!! Bring household hazardous waste to the Santa Cruz County Household Hazardous Waste drop off location. It is FREE for Santa Cruz County residents. For information call 831-454-2606.

Sanitation Operations is conducting an investigation and has alerted the Santa Cruz County Sheriff's Department and the County Department of Environmental Health. If you have any information regarding this matter, please contact the Environmental Compliance Unit at 831-477-3907.


NEW STAMPS

In celebration of the 50th anniversary of the National Marine Sanctuary System, the U.S. Postal Service recently released a new series of stamps that depicts the abundant wildlife and diverse ecosystems that can be found in the waters of America's national marine sanctuaries and marine national monuments.

A queen angelfish, a sand tiger shark, a hump-back whale, and the Farallon Islands are just a few examples of the marine life and marine ecosystems that are featured in the 16 new National Marine Sanctuaries Forever® stamps. A map of the National Marine Sanctuary System is printed on the back of the pane.



COVID RESOURCES

You can still use your expired athome COVID test, according to FDA

The U.S. Food and Drug Administration recently extended the shelf life of several at-home over-the-counter COVID-19 diagnostic tests, saying many can be safely used for six months beyond the expiration date listed on the packaging. This includes the free tests distributed by the federal government. For a list of authorized tests and their updated expiration dates, visit the FDA's website HERE.

Anyone on Medicare is eligible to receive 8 free Covid tests per month

Request yours from your local pharmacy. Some private insurers are also covering them, in which case you may have to submit a reimbursement

request if the pharmacy charges you. Not all insurers cover the cost, so check with yours first.

Updated COVID vaccine is now widely available

The bivalent COVID-19 vaccine is now available. and free. Eligibility: anyone age 12+ for the Pfizer one and 18+ for the Moderna one. This vaccine will give you protection against the current omicron variants as well as the original Covid strain. FOOD

Drink Coffee That's Friendly to Birds

That's the recommendation from the Monterey Audabon Society (MAS). Tropical forests are the most important reservoirs of Earth's avian biodiversity, and the most threatened habitats in the world as well. Conversion of ancient forests to agriculture--grazing lands, soybean production, and coffee--are all chief culprits in the decline of Earth's last bastions of tropical diversity. MAS recommends buying Rainforest Alliance Certified or



Shade-Grown/Bird-Friendly coffee. Although a coffee may be labeled as fair trade or organic, this does not mean it was grown in a manner friendly to birds. Shade-grown coffee creates understory and complexity allowing for some threshold of avian biodiversity to persist amidst coffee production.

RECIPE CORNER

Slow Cooker Angel Chicken

Yield 4 servings
Prep Time 5 mins
Cook Time 4 hrs
Total Time 4 hrs 5 mins

Ingredients:

- 4 boneless chicken breasts
- 1 (0.7-oz.) packet Italian dressing mix (like Good Seasonings brand)
- 4 oz. cream cheese, room temperature
- 3 Tbsp. butter, room temperature
- 1 (10.75-oz.) can cream of chicken soup (see note below)
- 3/4 cup chicken broth or white wine
- cooked angel hair pasta

Instructions:


- 1. Place chicken in the crockpot.
- 2. In a saucepan, combine Italian dressing mix, cream cheese, butter, soup, and broth. Heat over medium-high heat just until cream cheese is melted and incorporated into the soup.
- 3. Pour sauce over chicken. Cover slow cooker.
- 4. Turn crock-pot on low for 4 to 6 hours. Serve over cooked angel hair pasta.

Notes:

- Feel free to substitute any cream of soup you prefer--cream of mushroom, cream of celery, cream of broccoli--as they all would all be great. You may also use 98% Fat Free and Healthy Request soups.
- Feel free to throw in some frozen broccoli or spinach into the crockpot with the chicken OR add fresh, steamed vegetables when serving.
- To stretch the number of servings, you may opt to shred the chicken with two forks after cooking.
