MINUTES:

Minutes from the Board of Directors Meeting held on September 8, 2014 were approved as presented.

FINANCIAL REPORTS:

Financial reports for the eight-month period through August 31, 2014:

Balance Sheet Report. Total funds on deposit \$1,060,764.

Operating Fund Report. Revenues total \$219,305. Expenses total \$193,525. Net change +\$25,780.

Reserve Fund Report. Revenues total \$153,515. Capital repairs total \$114,079. Net change +40,379.

Aged Receivable Report. All members are current with four exceptions. Four owners are one month or less past due, (\$1,696); ten owners have prepaid dues, total - 6,571.

ON-SITE MANAGERS REPORT:

Scott Thomas reported to Directors, in a written report, on items for the current period ending September 31, 2014. A copy of the report is made a part of these Meeting Minutes.

RECAP OF WORK ORDERS AND CORRESPONDENCE:

Michele reported a recap of work order requests and correspondence.

NEW WORK REQUESTS:

LANDSCAPE COMMITTEE:

Scott is identifying Miraporum trees to spray for thripe and has identified leaks on two pumps.

ARCHITECTURAL COMMITTEE:

A motion was made to add electronic submission of building plans on the ARC applications, seconded, and passed unanimously.

SOCIAL:

OLD BUSINESS

Painting – Section A. Jesse Gulling Painting has completed painting of 29 units units, clubhouse and pool house. The Board was very pleased with his work and completing the job on schedule. A notice was sent to all homeowners in Section A asking them to identify any areas of concern on their unit that are in need of corrective action before releasing final payment to the contractor.

Paving – A motion was made to ratify and approve Henry's execution of the paving contract, seconded, and passed unanimously.

A motion was made to pay the Granite Rock invoice in the amount of \$288,000 with the contingency to reserve the right upon Canon Del Sol's request in the next six months to fog seal designated areas and repave the soft area on Canon del Sol as identified in exhibit A, seconded, and passed unanimously.

Review 2015 Proposed Operating & Reserve Budget. The Board reviewed the draft Operating & Reserve budgets included in their packets. Tabled until November.

Fall Creek Engineering Invoice. The Board reviewed the invoice from Fall Creek Engineering in the amount of \$890. At the August 4 meeting the Board authorized Fall Creek Engineering to do a feasibility study for possible use of waste water for irrigation purposes not to exceed \$500. A motion was made to pay the invoice for the full amount of \$890, seconded, and passed unanimously.

Review CC&R's, Policies and Practices. Mary Ann volunteered to lead the Board's review of the Policies and Rules and Regulations and advise of updates that are needed to correspond with the CC&R's.
