### PRESIDENT'S MESSAGE

Greetings,

As the year wraps up, I wanted to take this opportunity to provide updates on some HOA projects that are underway and will carry over into next year. The engineering and design of the replacement retaining wall for the sewage treatment plant is completed. We are having a review done by the sanitation department prior to submitting it to Santa Cruz County for the required permit. We will select a contractor for the construction while the plans are being reviewed. I anticipate this project to be completed by mid year. We most likely will need to do some landscape work in conjunction with this as the work needs to be done from the outside perimeter behind the homes at 455-467 Canon del Sol.

Early in 2020, the board adopted a plan for the daily opening of the clubhouse. The board chose to delay the opening during the pandemic. We are now comfortable with opening the clubhouse under the current indoor masking guidance that has been put in place by the County and State. The rules for use are located on our website, and the hours will be the same as the spa and pool (9 am to 10 pm). Our security team will include the locking and unlocking of the clubhouse doors as part of its daily routine. See more information on page 5.

We have installed security cameras in the clubhouse and will be installing exterior security cameras at both the

pool and clubhouse. We also will be improving the Wi-Fi network, which will increase the signal around the pool, BBQ gathering area, and tennis courts. In addition, we will be repairing or replacing the front and inside doors, and investigating a new key card system for access. Other projects for next year include Section B painting and staining, landscape irrigation updates, and drip conversion.

At this month's meeting, the board also reviewed the comprehensive analysis that David O'Rouke provided on the possible adoption of solar for the HOA's electricity use. We agreed to enter into a fully refundable, non-binding agreement with Altera Solar for the design and confirmation of the full benefits to the HOA. The board will review this information in January and vote on next steps. We will be publishing all information about this possible project on our HOA website as it becomes available. Please feel free to contact me or with any questions or concerns.

Thanks for continuing to be safe and wearing a mask when necessary!

Q. Where can I find more information regarding native plants?



# MONTEREY BAY BIG TIDES AHEAD

California King Tides will be here January 1-3. King Tides are high tides that occur when the gravitational pull of the sun and the moon are in alignment. King Tides are typically accompanied by dramatic negative tides. Most tides in California are mixed semi-diurnal. That means we typically get two high and two low tides in a 24-hour period. Here's what to expect the tide highs and lows to be:


#### CDS "Cats (and Dogs) in the 'hood" by Karen McCarty (436 Oyster Drive)




