President's Message

Meetings of the Canon del Sol Board of Directors are normally held monthly on the first Monday of the month. This month because of the Labor Day holiday, the meeting was held on September 9. Items of note include the following:

1. First and foremost, Scott Thomas informed the Board that he plans to retire effective at the end of the year. I personally, and the Board individually and collectively, wish to thank Scott for all of his efforts on behalf of the HOA over the ten or more years he has acted as our onsite manager. He has been a tremendous help to me and homeowners and will be missed.

Looking forward, the onsite manager position will accordingly come open. I ask that anyone with an interest in the position contact me. I also welcome your comments and suggestions with respect to the position. My email address is hbose@sbcglobal.net.

2. As previously mentioned, we will be repaving some of the parking areas and seal coating the roads within the development. The parking space repaving is currently scheduled for the second week in October with the resealing the third or fourth week of October.

The repaving work should not prevent normal traffic flow for any significant period of time, however, there will be restrictions on driving and walking on the newly sealcoated roads for some period of time. More information will be forthcoming regarding these restrictions as the time for the work nears.

3. The Board has agreed to open up the Clubhouse for homeowner use and to make improvements therein including painting, carpet replacement and upgrading the lighting. At the last meeting, the Board received a report from a committee of homeowners with recommendations regarding these improvements.

The Board determined to go forward with the recommendations regarding Clubhouse painting. This work should start in the very near future if not by the time you receive this newsletter.

Improvements will continue through the balance of the year. If anyone is planning to rent the facilities, please contact Scott so that we can attempt to avoid schedule conflicts. Finally, in this regard, the Board thanks the committee for its work in making this project a reality.

4. The Board has taken the first step in implementing a policy restricting short-term rentals by adopting a rule prohibiting rentals of less than 30 days. This rule will be circulated to owners for comment. The comments will then be reviewed, considered and adopted, amended or rejected by the Board at its November meeting. The rule cannot go into effect until this process is completed in accordance with legal requirements.




RESIDENTS' NEWS: "Sniffing" Around for Gas Leaks

One of our CDS neighbors recently detected the smell of gas coming from the cabinet that houses her PG&E gas meter. She called PG&E about her concern, and PG&E sent a service technician within fifteen minutes.

It turned out that there was, in fact, a leak in the exterior pipes that led from the ground through the wall to the meter (which is enclosed in an exterior cabinet).

The technician replaced two extremely corroded pipes at the location of the leak, which she surmised were in poor condition due to their age and the surrounding salt air. The technician also replaced the gas meter at this location and checked all of the gas appliances in their home (including the two fireplaces). The technician even adjusted the simmer settings on the burners of their gas range.



We should all check for gas leaks. If your gas meter is housed inside an exterior cabinet, open it and check to see if there is

a smell of gas there. Also check around

your gas meter. Thank you to Chris Garcia (443 Santa Monica) for sharing her story so that we

Don't Fall for Phone Scams

This message was provided by a La Selva Beach neighbor via the Nextdoor social media site for neighbors regarding a kidnapping telephone scam:

"I got a call a week ago that started with the voice of a teenage girl shouting "Daddy, they've got me in a van!" Luckily a friend of mine had told me about this scam, but it's easy to fall for it.

"First of all, if you do have a daughter, don't say her name. The way it plays out is that they say they have your daughter and run you through up to 48 hours of getting cash from banks and doing drop offs, while requiring you to stay in constant cell phone contact the whole time.

"My understanding is that they tend to work geographic areas and since I got a call here, I thought I'd post a warning. I have reported this information to the police, but the criminals use throw-away cell phones and can't be tracked. Think before you speak, and don't give them any information that they can work with to convince you it's real."

There are a lot of phone scams out there. Remember, never provide:

- (1) Social security number
- (2) Bank account numbers
- (3) Credit or debit card numbers
- (4) Passwords

In general, no credible business will call you to gather your personal information. These are always scams. Either simply say "No thanks," and hang up, or just hang up. You are never



under any obligation to speak with strangers.

DoorDash Comes to La Selva Beach



Did you know that the internet restaurant delivery service DoorDash now serves La Selva Beach? Like the somewhat better known UberEats, this service lets you use your smartphone to order home delivery of a wide variety of foods from nearby restaurants (UberEats is not yet available in our neighborhood).

To use DoorDash, you simply download the DoorDash iPhone or Android app, and register a credit card. The app will then display a wide variety of different food styles (American, Chinese, Mexican, Italian, etc.) from about 20 restaurants in our area. You order breakfast, lunch or dinner, and you get an immediate acknowledgement of the expected delivery time (usually well less than one hour), as well as text messages on the status and location of the order.

DoorDash adds a service charge to the normal restaurant prices (and the driver will always appreciate a tip).

Sometimes it's just more convenient than cooking or driving out!

Parking is limited, so carpooling is recommended whenever possible.


The Castro Adobe is located at 184 Old Adobe Road, Watsonville. Take Highway 1 to the Buena Vista exit. Drive east on Buena Vista until the Larkin Valley Road intersection stop sign. Diagonally, going up the hill to the left is Old Adobe Road, a one lane private road. Travel up Old Adobe Road approximately one mile. The Rancho San Andrés Castro Adobe State Historic Park is on the right side of the road.

NFL at 100


Bookshop Santa Cruz Thurs., Nov. 7; 6-8 pm

Generally regarded as the best wide receiver to ever play in the National Football League, Rice is now a television personality in both sports and entertainment.



Get Your California Real ID by October 1, 2020



For commercial air travel on and after October 1 of next year, you will need to show your California Real ID driver license or a valid passport. You also will need a Real ID to enter federal buildings and visit military installations.

To be safe, getting your Real ID sooner than later is a smart thing to do.

Here's what you need to do if you haven't already done so:

- Make an appointment online at: www.dmv.ca.gov or 1-800-777-0133
- Cost is \$35 (same as regular license)
- Bring along the documentation requested by the California DMV at: http://tiny.cc/wtescz
