Canon Del Sol Homeowners Association [HOA] Temporary Rules for Swimming Pool Use

June 17, 2020

Note: These rules are effective immediately upon pool opening and will continue as needed based on guidance set forth by the Santa Cruz County Environmental Health Division (SCCEHD). They are in addition to existing rules, including posted rules at the pool area. At this time, public spas, hot tubs, and saunas are not allowed to operate until further notice. It is the responsibility of HOA members to follow these rules and to ensure that their Renters agree to follow these rules.

These rules are intended to minimize the potential for exposure to the COVID-19 virus when our CDS community members use the swimming pool. If the rules are not followed, including sign-up and proper disinfecting, we will have no choice but to reclose the pool.

Please immediately inform Anderson & Company [831] 722-4048 if you or one of your guests shows symptoms or tests positive for the COVID-19 virus AND have used the pool in the last 14 days.

GENERAL

- 1. Do not enter if you have fever or cough.
- 2. Maintain 6 foot distance from others when entering and exiting the pool area.
- 3. Allow time to collect all your belongings and trash, sterilize and leave the pool area prior to the next reservation.

DISINFECTION

In order to maintain a safe and healthy community pool facility anyone who uses the pool area agrees to disinfect common touch points before and after their usage, as required by the SCCEHD.

- 1. Using provided sanitizer, disinfect by wiping down all chairs, tables, entry/exit gates, pool handrails, door handles, shower handles, restroom facilities and all other common touch points.
- 2. Pool users are encouraged to provide and use their own hand sanitizer.
- 3. Use of the Pool Area is limited to 12 people at one time.
- 4. Restrooms –restrooms are available for use and must be disinfected if used.
- 5. Furniture one table, four chairs and two lounge chairs will be available for use. Other pool furniture will not be available for use during this time.

RESERVATIONS

Usage of the swimming pool will be by reservation only. Reserved use is for Members, Renters, and their invited guests, who are currently within the same social distancing "bubble."

- 1. Do not enter the pool area without first completing the reservation schedule.
- 2. Pool reservations will be made by means of signing up at the pool entry using a posted reservation schedule. Please be prepared to use your own hand sanitizer before and after using the provided pen. Retain a photo of the reservation schedule once you have signed up to help prevent mix-ups.
- 3. Reservations can be made up to one week in advance.
- 4. Reservations will be made in 1 hour increments, with a maximum of 1 hour per group or person (in advance). If at the end of your reserved time, no reservations have been made immediately following your time, you may choose to extend your reservation in 1 hour increments.
- 5. Pool hours remain 9am until 10pm.
